## MINUTES

### OLD BUSINESS:

- 1. Minutes of May 31, 2001- I Executive meeting:** These minutes were corrected. To be e-mailed to Santos and Goodsell.  
**Motion:** To accept Minutes of May 31, 2001 as corrected. **Carried** Santos/Penstone
- 2. Treasurer's Report by Penstone:**  
Note line 24 \$686.04 to Kilpatrick for Cottage Watch signs  
Penstone to e-mail abbreviated version of treasurer's report to refresh website. Also used for AGM.  
**Motion:** To accept the Treasurer's Report. **Carried** Goodsell/Capell
- 3. Annual General Meeting:**  
July 18, 2001 @ 7:00 p.m. @ United Church Hall  
Goodsell has arranged booking of hall and refreshments: will require donation cheques for United Church (\$25) and UCW (\$50) – same amounts as last year.  
Penstone to have name tags, extra copies of newsletter, Treasurer's Report (Jan.- June), membership forms. Meeting packages (includes newsletter, treasurer's report, water quality, 2000 AGM minutes) and will be numbered for draw for a cottage watch sign.  
Truyens: Handout cottage watch magnets and brochures,  
Kilpatrick – safe boating guides/bookmarks, brochure "Living by Water",  
Santos – water quality package  
Santos distributed signs and will post signs around Delta: Carol's Grocery store, Liquor Store, Bank  
Truyens will post signs around Lyndhurst: Wings, Post, Grocery Store, Lumber Yard, Gift shop  
Kilpatrick invited two council members from each of Twsp Rideau Lakes and Leeds & 1000 Islands and the supervisor of Twsp park. Reeve Ron Holman of Rideau Lakes has replied yes, others have not formally replied.
- 4. Water Safety/Safe Boating:**  
**Outreach:** LBL Park still handing out pamphlets – haven't required more, though; LCBO seems to be a good distribution point for Safe Boating Guides: 45 as of June 25 2001  
**Safe Boating Guide:** Kilpatrick confirmed the latest revision is January 2000. Kilpatrick has requested 10 copies which were received June 28.  
**Discussion:** Kilpatrick will summarize changes to Safe Boating Guide on one page to be inserted into 1999 Safe Boating Guides for handout. Should be relevant to LBL, no trivia, telegraphic.  
**Pleasure Craft Operator: Course / Exam:** Kilpatrick confirmed it is "Go" with 11 registrants as of June 24. Kilpatrick is in process of notifying all concerned. Reduced fee for LBLA will be honoured. If pre-registered, you're guaranteed a position. Kilpatrick will announce at AGM.  
**Motion:** To give the United Church \$25 for the use of the facility for this course.

- 5. Cottage Watch:**  
Truyens reports sold 5 signs, 21 new members signed up.  
Truyens to define candidate roads where unsold signs could be posted, should check fire departments and

Kilpatrick sent addresses, phone numbers to Truyens for funding for road signs.  
Truyens to work on revised participant response letter.

### 6. Water Quality / Level Measurement Program:

Santos has called, e-mailed, written for more Phosphorus tests, but unsuccessfully. Will report at AGM.

### 7. Fishery on LBL

**Volunteer Angling Survey** – Kilpatrick confirmed that Ted Brett would report at AGM, bring a supply of report forms and try to recruit volunteers in addition to the list Kilpatrick had given him. Kilpatrick also provided Brett with a list of contact persons for drop-off points for Angling Survey forms.

**Near Shore Community Index Netting Report:** Kilpatrick received report: 47 pages, much statistics and scientific methodology; no conclusions or recommendations. Kilpatrick sent request to MNR, Scott Smithers, new biologist for Leeds, that second round of NSCIN be conducted on LBL in Summer 2003 or earlier. Kilpatrick sent copy of LBLA "Fishing 2001" to each of Bendig, Smithers for their comments but no response yet.

Kilpatrick to summarize for AGM package and Brett to report at AGM.

Kilpatrick expressed shock that a person not named to the Nominating Committee at LBLA 2001-I actively participated. Santos responded that we followed LBLA common practise, which is to include past presidents who are available.

### 9. Signs at Boat Ramps: Kilpatrick and Goodsell agreed on final wording. Kilpatrick had one proof sign made.

Made changes to spacing. Proof sign will be used at Kendrick Park ramp. Second proof has been ordered. Four will be made. Kilpatrick will collect old signs at the end of the season, re-furbish the mounts and mount new signs for placement in summer 2002.

### 10. Other Initiatives:

Take a Little Lead Out: Claire Angermann to report at AGM.

Loon nesting platforms: Kilpatrick ascertains that MNR recommends removal over the winter. Santos will ask Earl Patric to talk about this and seek volunteers.

Kilpatrick and Frank Ellis intend to construct two more in the summer of 2001 and arrange for placement ASAP after ice-out in spring 2002. Penstone is to retrieve invoices from year 2000 and send them to E Patric to use to document expenses for the grant. In 2001, Kilpatrick will submit claims directly to Penstone, Penstone and Patric to obtain funds from CFWIP.
